#### 8. GENERAL MANAGER'S REPORT

#### A. FINANCE/TREASURER's REPORT

Paul J. Kaymark CPA, Financial consultant, reviewed the Profit and Loss/Balance sheet statements from July 2021-June 2022 compared to July 2020-June 2021. Total Income for 2021-2022 FY is up \$26.06 from the previous fiscal year. Total Expenses were up in several categories for a total of \$147,290.27 mostly due to additional salaries, wages and benefits from adding new employees. Net Income at \$781,047.68 compared to \$961.443.12 from previous year. Total in Cash is up \$701,716.97 compared to the previous year. Total Assets is also up \$763,861.22 for the year. Overall 2021-2022 was a better year financially compared to 2020-2021 according to this report.

#### B. ACD UPDATE

General Manager Mendoza presented the monthly update for the ACD to the Board. He reports there were 19 total funerals in June. Of the 19, 15 were full burials and 4 were cremations. The ACD also sold 5 Pre-need plots. We are still waiting on the LAFCO application. In grounds special projects, the painting of the perimeter wall has been completed. This week there was also a volunteer helping the grounds crew. The Database program, we just received an email the data is almost ready to be uploaded. There are interviews lined up this coming week for the new PT Office assistant position. The Monolith Rock and Pedestals are due to arrive next week on Wednesday. The foundation for the Rock was already set by our grounds crew. There are no upcoming conferences planned.

#### C. COVID-19 PANDEMIC PROTECTIVE MEASURES

There are no changes to the ACD protective measures, although the County is considering reinstating the mask mandate for indoors. The grounds crew is continuing to clean and sanitize.
