#### 8. GENERAL MANAGER'S REPORT

A. FINANCE/TREASURER's REPORT

Paul Kaymark, Finance Consultant, informed the Board that there were greater sales than expected in Program Services. Total General Fund Revenue was \$1,392,109. He informed the Board that General Manager Mendoza was able to keep expenditures within budget even though there was an explosion in revenues.

Trustee Palhinha hopes that Supervisor Hahn is aware of the transformation. He commended General Manager Mendoza. He also commended Paul Kaymark, Finance Consultant, for explaining in detail the information.

Chair Wada stated that in response to Trustee Palhinha's comments and questions, his assumption has been that given the involvement of the County's legal department, that what is in process is the interment restitution to our fund and that it should happen at some point.

Trustee Laughlin motioned to approve the Finance Report. Seconded by Trustee Palhinha. **Approved** 

## B. ACD UPDATE

General Manager Mendoza indicated that there were a lot of funerals for the month of June. He created a chart that informs the Board of the number of interments and pre-need sales, year to date.

Trustee Laughlin requested further information on the sprinkler system and timers.

General Manager Mendoza informed the Board that the ACD uses reclaimed water to water the grass, and that the enclosure (fence) by the trash dumpster has been completed. Concrete benches are being painted white.

## **10. ACTION ITEMS**

## A. ACD FINAL AUDIT REPORT FOR FYE 2019 & 2020

Paul Kaymark, Financial Advisor, presented the 2019 & 2020 Financial Audit Report. Requested that the Board receive and file the report as is and explained that the 2020 Audit is clean.

He also presented a 1-year engagement letter from a new auditor for this coming audit season, August 2021. Informed the Board that financial statements will be ready for the auditor to audit in September and auditor will present the audit report to the Board, October of this year.

General Manager Mendoza is anxious to get the 2021 Audit done because the two audits (2020 & 2021) will place us (ACD) in a much more favorable position for credit.

Chair Wada stated that he expected to see an executive summary of the Audit Report that would verify that practices are clean and appropriate in which he did not see.

Trustee Palhinha agreed with Chair Wada and expressed his concern regarding the need to separate the style of the new Board from the previous Board including the work that General Manager has done. He indicated that it should be done in writing.

Trustee Laughlin motioned to receive and file the Final Audit Report for FYE 2019 & 2020. Seconded by Trustee Gonzalez. **Approved** 

B. RESOLUTION 2020-011 ADOPTING CERTAIN ADJUSTMENTS TO THE DISTRICT'S CURRENT FEES AND APPROVING NEW FEES CHARGED FOR THE SERVICE PROVIDED BY THE DISTRICT

General Manager Mendoza justified the recommended adjustments to the district's current fees.

Trustee Palhinha motioned to approve and adopt Resolution 2020-011 Adopting Certain Adjustments to the District Current Fees and Approving New Fees Charged for the Service Provided by the District. Seconded by Trustee Laughlin. **Approved**
