3. BOARD COMMENTS

Trustee Palhinha is proud of all the Americans, all the doctors, nurses, police, fire fighters, paramedics, everybody. He sees all the sacrifices that they are going through at this moment; is very emotional about it and is going to pray for them; and asked everybody, all his colleagues to do the same.

Trustee Stewart thinks that it is awesome that everybody can take time and sit down and do this because of the difficulties; it is frustrating not to be able to see everyone; appreciates that we can still do this.

Trustee Gonzalez wants everybody to stay safe, make sure to protect yourself and your families; remember to put God first, your children and your families, eat healthy, wash your hands: informed the Board that

she and Chair Treviño have been delivering food to senior citizens in Artesia. A lot of them cannot leave their homes. She and Chair Treviño are picking up that challenge to deliver food to them. They are taking donations; they delivered food to 10- 12 families on Saturday, were gone all afternoon delivering food; asked to keep everyone in your prayers, especially she and Chair Treviño so that they can continue to do this.

Vice Chair Wada requested clarification with meeting dates on April 23rd, May 7th, and May 14th. Wished everyone well and to be safe; it is hard to be sequestered inside the house but must be done. All it takes is one person and the whole thing explodes again.

Chair Treviño thanked Ana for the work that she does and appreciates her working during this time, has not forgotten about her and appreciates her and all the staff especially during these times that are unprecedented; stated that sometimes meetings may be a little contentious; there are always five people that is what you call a democracy; please understand that when things are brought forward, they are brought forward for a reason; spent time over the last week speaking to other cemeteries about their finances and their processes; spoke to two accountants and will continue to do research outside of his two hours that he dedicates to a meeting; he takes it serious as everyone does; he does research on items on the agenda; calls and looks around because he has to make a vote that is going to affect tax payer dollars, constituents and the residents that live in the cemetery district; knows that if they would have had safety valves prior to their team, there would have probably been a different outcome; there is a lot of money that is gone. If we had two check signers back then, a lot of it would still be here; when he brings something to the table, he respects his colleagues, does not bring it for the fun of it or to waste time. He brings it because he felt it worthy enough to come back; Board is focused and respects the Board's opinion and vote; please be safe; thanked Trustee Gonzalez for always being out there with him, regarding everything that they do in the community; has been in the community 11 years and Trustee Gonzalez has always helped out with everything that he has ever asked; she asked him to help, have been out there for many years, and appreciates it; loves everyone on the Board; asked everyone to be safe, stay home; wash your hands, wear a mask, get some gloves, help each other by helping yourself it is perfectly fine to be selfish during these times because if you are selfish in taking care of yourself, you are taking care of everybody else.
