8. GENERAL MANAGER'S REPORT

A. FINANCE/TREASURER's REPORT

Paul Kaymark, Finance Consultant, presented to the Board the overall operation balances. Total General Fund Revenue was at \$1,229,870. The total in Accounts Receivable was \$257,926 for the month of November. Total Revenue overall for the year so far has a 61% increase over what was budgeted.

The Board discussed missing text on the check detail report. General Manager Mendoza provided more information on each entry that was missing text details.

Trustee Palhinha motioned to approve the November 2021 Financial Report. Trustee Laughlin seconded. Unanimous approval.

B. ACD UPDATE

General Manager Mendoza informed the Board of the of number of interments for November. There were 10 interments total; 3 double depth, 6 single and 1 cremation. There were 4 pre-need sales. The tree trimming is complete, although the tree trimming company will return to address trees by the fence that a neighbor has concerns about. The architect James Mickartz is still being consulted regarding the preliminary cost numbers to create a budget for future projects. The grounds crew has been very active in removing tree stumps and adding new sod in bare areas. They have also been lifting and aligning headstones that need attention.

C. COVID-19 PANDEMIC PROTECTIVE MEASURES

General Manager Mendoza notes that there are no updates or changes from the County. The Board discussed the vaccination status of the Board of Trustees. A suggestion was made of testing prior to meetings for any members not vaccinated. The Board discussed whether a Zoom meeting would be better than the current teleconferencing. The many factors that need to be considered were discussed including personal beliefs, requirements, Supervisor Hahn's directives and organizational best practices.
